Course Overview

This course is a survey of the analytic study of culture, both as cause and effect, in sociology. We will survey the literature in the sociology of culture, with an emphasis on current approaches to the theory, measurement, and assessment of culture. The course should stimulate ideas for empirical work in cultural sociology and offer cultural tools for application to empirical research in social science and beyond.
